- § 3 If anything were to happen to the car, internally or externally, I owe the cost of repair or the excess for the insurance.
- Any fines issued during the lease I take full responsibility to pay. <u></u>

- § 5 If I fail to deliver the car keys on time, I will pay the fine of 500 crowns, SEK.
- §6 If I return the vehicle not cleaned after usage, I will pay the fine of 500 crowns, SEK. The Intendent has complete authority to decide whether the car is cleaned or not. In case the vehicle is untidy when I am first about to use it, this must be reported to the the Intendent.
- § 7 Any errors noted in the Drivers log made of the previous lessee are immediately reported to the The Intendent. The Bruno-intendent has complete authority to decide who is responsible to pay for the missing kilometers in the log.
- When the gas tank drops below <sup>1</sup>/<sub>4</sub> I must refuel. I will save the receipt and fill a "Blankett för utlägg" § 8 for compensation, these are found in the lounge.
- § 9 I am aware of and will follow the rules stated on the website of the section Mechanical Engineering, www.mtek.chalmers.se.
- § 10 Payment is made within 30 days after the invoice is sent. In case of late payment, an additional fee of 5% of the total amount of the invoice will be added.
- §11 As a lessee, I am responsible for ensuring that I and only those who are on the contract are allowed to drive the car during the rental period and that in case of abuse, I pay a fine of SEK 500, SEK.
- § 12 Responsible for all drivers having a valid driving license for driving in Sweden.
